

## TERMS AND CONDITIONS

By participating in this competition, you are deemed to accept the below Terms and Conditions and to have agreed to be bound by them.

**1. Promoter:** The promoter of this promotion is Gallagher Group Limited (“Gallagher”, “we”, “our”, “us”).

**2. Eligible Entries:**

- (a) To be eligible to participate in this competition, you must be a NZ resident that is 18 years or over; and
