

2026 NZ Auto Weigher Giveaway

Competition Specific Terms and Conditions

By entering this Promotion, entrants agree to be bound by these Terms and Conditions.

1. Promoter

1.1 The Promoter of this Promotion is Gallagher Group Limited (NZBN 9429040076591), of 181 Kahikatea Drive, Melville, Hamilton 3206, New Zealand ("Gallagher", "we", "our", "us", "the Promoter").

1.2 This Promotion is not a form of gambling under the Gambling Act 2003. Entry is obtained by purchasing eligible products at their normal price, and no separate entry fee or payment is required.

2. Promotion Period

2.1 For every \$500 spent on a 'Weighing and EID Hardware Purchases' between 1 Sep - 30 Nov 2026 (inclusive) (the "Promotion Period") is eligible for one (1) entry into the Auto Weigher draw.

2.2 'Bonus Entries' can be awarded for past purchase behaviour and future device/software usage, outlined in point 4.

2.3 The Promotion will be drawn at 12:00pm (NZT) on Friday, 4 December 2026, at Gallagher's registered office at 181 Kahikatea Drive, Melville, Hamilton 3206, New Zealand, as set out in Section 6.

2.4 Entries received after the end of the Promotion Period will not be accepted. Incomplete or illegible entries will be treated as invalid.

3. The Prize

3.1 The prize is one (1) StrongBó Auto Weigher unit (hardware only) (the 'Prize'), with a total value of NZD \$22,310 (including GST), based on Gallagher's recommended retail price as at 24/08/2026.

3.2 For the avoidance of doubt, the Prize does not include:

- any StrongBó Auto Weigher App or Gallagher Animal Performance software subscription;
- cellular data, SIM, or connectivity charges required to operate the Auto Weigher;
- any ongoing maintenance, consumables, or third-party integration costs.

3.3 The Prize is not transferable, exchangeable, or redeemable for cash, in whole or in part.

3.5 If the Prize (or any part of it) becomes unavailable for any reason, Gallagher may substitute an alternative prize of equal or greater value.

3	Bonus entries are earned when the entrant creates uses an Animal Performance (AP) account and its features with the promo period. No customer redemption is required for this activity, as entries will be tallied and attributed from AP account data.
