BY INSTALLING AND/OR USING THE SOFTWARE YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE DO NOT INSTALL AND/OR USE THE SOFTWARE AND CONTACT THE AUTHORISED DISTRIBUTOR WHERE YOU OBTAINED IT FOR FURTHER INFORMATION WITHIN 30 DAYS OF RECEIPT OF THE SOFTWARE.

2. **Permitted License Uses and Restriction.**
 - a. Subject to the terms and conditions of this License you are granted a limited non-exclusive license to use the Software in a single instance on a single server. This License does not allow the Software to exist on more than one server and/or in more than one instance at a time and you may not distribute or make the Software available over a network where it could be used on multiple servers at the same time.
 - b. You may make one copy of the Software stored on your server in machine-readable form for backup purposes only, provided that the backup copy must contain all copyright or other proprietary notices contained in the original.
 - c.  - a.
